

# Application with medical confirmation to obtain a mobility aid bike pass.

With the mobility aid bike pass, the holder can bring an orthopaedic aid (e.g. tricycle, recumbent bicycle, adult walking bike, hand bike) for personal mobility on public transport free of charge.

The tariff rules for self-service loading of bicycles apply to orthopaedic mobility aids. It must be possible to load and unload all mobility aids independently at any time. The mobility aid bike pass is valid for one year, is personalised and is integrated into the SwissPass.

## Important.

No mobility aid bike pass is required for rollators, wheelchairs and electric mobility scooters (as per T600, section 7.3.3).

Tricycles and recumbent bikes are considered special bikes and are excluded from carriage by some transport companies.

## 2 Passport photo.

We require a current high-resolution original passport photo for your SwissPass. Your photograph will be stored electronically for a maximum of ten years (max. five years up to the age of 25).

### Requirements.

- Front shot
- If possible, eyes open and not covered
- Monochrome background
- Even illumination (no shadows)
- Sharp and high-contrast
- Format approx. 35 × 45 mm
- No scanned or home-printed paper photos

**4 Medical confirmation for obtaining a mobility aid bike pass.**

- Only persons whose personal mobility is significantly restricted without the use of a mobility aid are entitled to a mobility aid bike pass. They are entitled if, for example, they can do without a (private) transport service thanks to a mobility aid. People who regain mobility without aids after a few days or weeks are not entitled to a mobility aid bike pass.
- With the mobility aid bike pass, the holder can bring their personal mobility aid required for everyday travel free of charge within the area of application for bike tickets in accordance with Tariff 600 ([allianceswisspass.ch/awbe](http://allianceswisspass.ch/awbe) – column T600 Bike ›yes‹). The conditions of the relevant transport company apply on all other routes.

**5 Period of validity and comments.**

The mobility aid bike pass is valid for **one year**. After one year, a new 'Application with medical confirmation to obtain a mobility aid bike pass' can be made to apply for another mobility aid bike pass. Holders of a mobility aid bike pass receive a reminder by text message or email on the first and last day of validity.

**It must be possible to load and unload all mobility aids independently at any time.**

This 'Application with medical confirmation to obtain a mobility aid bike pass' is valid for six months from the date of issue. This form will be destroyed once the mobility aid bike pass has been issued. In the event of a dispute, a second 'Application with medical confirmation to obtain a mobility aid bike pass' may be requested from a different doctor.

**For mobility assistance, the tariff rules for self-service loading of bicycles apply in accordance with Tariff 600, section 7.**
